CREDIT TERMS AND POLICY

For Customers with approved credit, Company extends open account terms consisting of the following:

- 1. Payment in full is due 15 days after invoice date.
- 2. A finance charge will be assessed at the rate of 18% per annum or 1.5% per month or the maximum amount allowed by law from date of invoice.
- 3. Company may shut off the supply of propane or refuse to deliver additional propane without terminating the Customer Agreement or Customer's obligations under this agreement, for non-payment of any charge for propane, merchandise, or service not paid within 30 days from invoice date. Company shall not be liable for personal injuries, property damage, losses or expenses resulting from the discontinuance or exhaustion of Customer's propane supply.
- 4. In the event that an attorney or agency is utilized to enforce or collect any obligation incurred by Customer, Customer shall be required to pay all reasonable counsel fees and disbursements of Company as permitted by law.
- 5. I agree that in the event any balance on my "regular open account" is past 30 days, Company may immediately charge my "Credit Card Account" with the credit card of record listed on the 1st page of this Residential Credit Application.

General Information: To ensure that your gas supply is always adequate, Company trucks are routed by areas. When a Company truck makes a delivery, a delivery ticket with a return mail envelope will be left even if you are not home. An invoice will be mailed to you.
